Contract No. DSHE/SESIP/1-289/Printing (GD 32)/2016/69; Date: 12/02/2017 (Tender ID No. 87250) by and between the Md. Abu Sayed Sk (Additional Secretary), JPD, SESIP and Nahida Islam, Proprietor, Nahid Advertising & Printing for the contract named Life Skill Development Materials (Training Materials) is amended as follows:

1. GCC Clause 31.4: Pursuant to GCC sub Clause 31.4 form ePG3-4 Technical Specification and Compliance of goods and related services Item No. 1 Sl. No. 2 is hereby revised from " Sheet of 65 numbers" to "sheet of 35 numbers".
2. GCC Clause 25.1: is hereby revised as the contract price shall be 54,93,550 (fifty four lac ninety three thousand five hundred fifty) instead of 75,36,525 (seventy five lac thirty six thousand five hundred twenty five). This change in contract price is a result of reduction in unit price from "88.665" to "64.630" per manual of 35 pages.

The effective date of this Amendment is 25.04.2017 or upon execution whichever is later.

ALL OTHER TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT SHALL REMAIN IN FULL FORCE AND EFFECT


